## Catering, Floral Décor & Design

Legendary Events owns The Estate and is the exclusive provider of Catering, Floral Décor & Design services at the venue and holds the alcohol license.

All food and beverage charges are plus a taxable Production Charge of 22% and 8.9 % Fulton County sales tax. The production charge covers the pre-planning, operational expenses and is not applied to the Facility Fee or Ceremony Fee (when applicable). Liquor service is taxed at 11.9 % per Fulton County sales tax regulations.

The Georgia State Liquor Commission regulates the sale and service of alcoholic beverages. As a licensee, Legendary Events is responsible for the administration of these regulations.

It is our policy, therefore, that liquor, beer and wine cannot be brought into the building. Alcohol services end at 2:00am. Sunday alcohol service cannot begin until 12:30pm. The Estate does not offer cash or consumption bars

The Estate adheres to a neighborhood 11pm sound ordinance.
